





NC BoS CoC Unsheltered Coordinated Entry Access

- Benefits of connecting people living unsheltered to the CE system:
 - Strengthens existing infrastructure
 - Connects people to emergency shelter
 - Connects people to services
 - Focuses on connection to permanent housing
- Defining roles:
 - CE Lead
 - Provider outreach: Engage with providers in the region to increase collaboration for outreach and access for people experiencing unsheltered homelessness
 - Evaluate monthly progress (SSO-CE check-in calls) on connecting people living unsheltered to the BNL
 - Support data entry in HMIS and CE project
 - Support Unsheltered PIT lead
 - Unsheltered PIT Lead
 - Regional point person for providers around unsheltered access (updated in NC BoS CoC Governance Charter and approved by Steering Committee on May 4, 2021)
 - Coordinate with regional CE Leads
 - Ensure data collection happens on all people experiencing unsheltered homelessness
 - Engage all providers/organizations/stakeholders to understand the process
 - Provide additional training to providers/organizations/stakeholders



- Regions should elect their Unsheltered PIT Lead by June 30, 2021
- NC BoS Regional CE Access: Andrea walked through data in each region, which the comparison
 of 2020 PIT count numbers to May 10, 2021 unsheltered households on the BNL. It was also
 noted this data includes information for households that called NC 2-1-1 and were entered into
 the HMIS Triage project.

 - CEC members asked for training correspondence to include information about who should attend the training and suggested a place on NCCEH's website for street outreach trainings and resources.
- Data collection
 - Nicole walked through an Outreach Contact form for CE project entry. It is a paired down HMIS form. Suggestions included adding language to reflect Social Security Number as optional and adding a notes section for any additional information.
 - HMIS data entry options include an HMIS outreach project or the CE lead entering data into the CE project.



- Regional next steps
 - Elect 2021-2022 Unsheltered PIT Lead by June 30, 2021
 - Gathering partners
 - Plan to ensure all counties are covered.
- July agenda (Unsheltered PIT leads must be elected by June 30, 2021)
 - Overview of all tasks and timeline
 - Planning worksheet for regions to identify responsible party for each task
 - Ongoing outreach (clients and providers)
 - Follow-up services (assessment/etc.)

Emergency Housing Vouchers

- HUD released Notice PIH 2021-15 (HA) Emergency Housing Vouchers Operating Requirements
- HUD is allocating approximately 70,000 Emergency Housing Vouchers (EHVs) to Public Housing Agencies (PHAs). These EHVs are to assist individuals and families who are experiencing homelessness; at imminent risk of experiencing homelessness; fleeing, or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking; or were recently homeless and for whom providing rental assistance will prevent the family's homelessness or having a high risk of housing instability.
- Continuums of Care (CoC) will have a critical role in this process:
 - Targeting: PHAs must work with community partners to determine the best use and targeting for EHVs along with other resources available in the community;
 - Referrals: EHVs will not be filled from PHA's current waiting list- all EHV's are referred from coordinated entry systems;
 - Eligibility: CoCs are responsible for determining whether the family qualifies under one of the four eligibility categories for EHVs.
- Reviewed the list of NC BoS CoC PHAs who were allocated vouchers and discussed local contacts and connections for outreach.
- Other important dates include:
 - May 10, 2021: EHV allocation announced (complete)
 - May 12, 2021: EHVs for CoCs webinar (complete)
 - May 24, 2021: PHAs must inform HUD of the number of vouchers the PHA will accept
 - July 1, 2021: Effective date for all EHVs
 - July 31, 2021: PHA and CoC must enter a Memorandum of Understanding

 - May 18, 2021, 3 PM Strategy for Targeting EHVs and Related Resources
 - May 20, 2021, 3 PM Making the Most of EHV Waivers
 - May 25, 2021, 3 PM Coordinated Entry and EHVs
 - June 1, 2021, 3 PM Pairing Services and EHVs

- Teresa working on parts of her home


HUD Emergency Housing Vouchers

- HUD has recently released 70,000 EHVs nationally to PHAs
 - Vouchers specifically for people at risk of homelessness, experiencing homelessness, who were recently homeless, or survivors of DV
 - Referrals must come through CE system
 - Each PHA enters into MOU with their CoC
 - Must have signed MOU by 7/31/21
- 14 PHAs within BoS were awarded
 - Need to decide what prioritization through CE system looks like
 - Want to gauge interest from RE subcommittee re who would want to be part of shaping priority (not totally sure what involvement looks like yet)

 - Deniece Cole

Prioritization Work Group

- Tasked with taking a critical look at CE and the VI-SPDAT
- Started by looking at data on access to CE vs Back@Home (through 211)
 - o Data on VI-SPDAT
 - White folks significantly overrepresented in high scores
 - o Data on Back@Home RRH

- BIPOC folks much better represented in highest prioritization
- Why do white folks seem to generally score much higher on VI-SPDAT than with Back@Home prioritization process?
- Limitation that HUD does not include data on Latinx/Hispanic clients
- Workgroup is going to explore 211 as an access point (particularly Mecklenburg and Lee counties)
 - Need to pull demographic data from 211 in particular in these counties

RE Dialogue Series

- In 2020, we held 4 sessions
 - Common consensus that series helped spread awareness and start conversations
- Do we want to revive the series this year?
 - Dialogue is nice but at some point we also need action
 - Interest in focus on policy and legislation, especially at local level
 - Need to update BoS CoC anti-discrimination policy to be more RE focused
 - Was a lot of work last year! Maybe only capacity for 1 or 2 this year
 - Maybe a topic for dialogue is CoC policies
