2021 Quarter One Taskforce Reports---

As a region it is crucial that we continue to ramp up our efforts to meet and collaborate with providers in

our counties to build these taskforces.

Rowan- Rowan Helping Ministries will be hosting a fair on October 16th. This will be used to allow the community to get involved. Providing informational resources to disburse into the community. Continuing to work on outreach as they work through transitions with staff.

- The Youth Homelessness Demonstration Project grant

Youth Grant Email

Good morning, Andrea.

The Youth Homelessness Demonstration Project grant has to applied for at the CoC-level, but there's some flexibility in how we define the geographic area. The work to get the grant application together would be collaborative with providers/leaders within that geographic area. The CoC gets to define the coverage area in the application, meaning that we could designate a county, a group of counties, a region, several regions, or the entire CoC. The biggest issue with applying for this grant is the large number of requirements that need to be met prior to application. We have had several regions that have been interested in applying in prior cycles, but they have been unable to get all of the pieces in place before the application deadline. If a region wanted to work with the CoC to apply for the grant, it must have an active youth advisory board, signed MOUs with child protective services and other social service agencies serving youth, amongst many others requirements in place before we even start. Most regions have found these requirements prohibitive,

and because the number of youth experiencing homelessness in the CoC has been relatively small in comparison to other populations, the CoC and most regions have not developed this infrastructure.
