- **Transitioning:** The meeting was not as productive due to group absentees: CA lead, and PIT lead, as well as no representation from Caswell or Chatham counties.
- **PIT:** All PIT data will be complied between January 25, 2017 at 6pm through January 26, 2017 at 6pm.
- Each county will compile data as usual and then send it to Faye Pierce, PIT Lead for PRACC
- Representatives from The VOA (SSVF) should be on the PIT committee. Kim reported that Burlington has an active member on their committee. Brian stated that was necessary to have at least one representative from SSVF to represent the Vets.
- Marlene advised will contact Verlanda Dawson, Rockingham County's VOA contact.
- Should hold at least 2 PIT PRACC conference meetings before Christmas then at least 2 such meetings before January 25.
- Webinar on Dec 8<sup>th</sup> from 10-11:30 should be attended by all PIT Leads.

  there are no homeless shelters in this area and that the Domestic
