#### **HMIS Transition**

NC BoS Governance Charter Updates

- NC BoS CoC Governance Charter updates are required to reflect new HMIS Implementation. The Steering Committee approved changes to the Governance Charter. The final NC BoS CoC Governance Charter is posted at: http://www.ncceh.org/files/6364/New HMIS Governance Body
- A new HMIS governing body has been created called the HMIS Advisory Board. This body connects the 3 CoCs (Orange, Durham, and NC BoS), covering 81 of the 100 NC counties.
- The governing body will have a total of 11-17 Advisory Board Members
  - o 2 representatives from each CoC
  - o 1 representative from the HMIS Lead Agency (NCCEH)
- o 4-10 representatives from other stakeholder groups Subcommittees will be created to oversee work and allow involvement from HMIS users. The HMIS Advisory Board has a Governance Charter that will be approved by each participating CoC. The NC BoS CoC Steering Committee voted to approve the HMIS Advisory Board Governance Charter. - o All HMIS training, workflows, forms, etc. will be hosted by NCCEH at ncceh.org and users will no longer go to nchmis.org, the website run by MCAH, for forms or training.
  - o Users will have a new ServicePoint website URL to log in to.
- What to do now:

## **ESG** Application

**Emergency Solutions Grant Funding Priorities** 

- Eligible activity types under ESG
  - o Emergency shelter o Street outreach
  - o Rapid re-housing
  - o Targeted prevention
- DHHS ESG Application Process
- o Agencies send applications to their LPA for approval and LPAs submit their agency applications and their regional applications to Department of Health and Human Services (ESG office)
  - o Local Planning Areas: in the NC BoS CoC, the LPAs are our Regional Committees.
- LPA ESG Competition
- o LPAs/Regional Committees are responsible for running the local competitive process of soliciting, reviewing, and selecting project application.
- Proposed ESG Funding Priorities
  - o Access to low-barrier shelter and rapid re-housing financial assistance and services
    - Homelessness prevention should be funded only in limited circumstances
  - o LPAs should apply for all available funding, with applicants most likely to receive funding
    - o Only applicants with high rates of spending should be funded
  - o Priority for programs that have integrated best practices, including low-barriers to entry, Housing First, and the NC BoS CoC's Written Standards

- o System Performance Measures were submitted on May 31
- o Renewal grantees have turned in their 2017 calendar year APR
- o The Scorecard Committee had their first call on May 30 and will meet again to finalize the draft of the new and renewal scorecards on June 6.
  - o The Steering Committee will approve new and renewal scorecards in the July 10 meeting.
- o Agencies have been submitting Intent to Apply forms and conducting follow up calls with staff.
- The Intent to Apply form is mandatory for all agencies applying for new CoC funds.
