#### Scorecard Overview

- Tool that helps CoC make ranked list decisions for funding
- o Two scorecards: new and renewal
- o Project ranking informed by funding priorities and scorecard
- o Increasingly looking at data to measure agency performance via points
- o 2021 Scorecard introduced an equity section
  - Intention to assign greater weight to these questions over time
  - Showing this group proposed edits for this year with greater weight
    - Discussion re race on board of directors:
      - Should it be reflective of people we serve or reflective of larger community?
      - o Should it be a percentage or proportional?
  - Is the subcommittee ready to approve this draft of the scorecard?
    - All in favor! Passes unanimously
    - Will now pass along to scorecard committee

#### **Case Conferencing**

Ashley VonHatten presented information on case conferencing.

#### Goals

- The primary objective of case conferencing meetings is to house people faster by using the region's by-name list of everyone experiencing homelessness.
- All participants contribute their experience, ideas, knowledge of clients, and institutional resources to figure out new ways of housing people.
- A successful case conferencing meeting is one in which everyone at the table shares a sense of purpose and community.

#### **Planning**

Questions to ask include: Is case conferencing scheduled at least bi-weekly? Are the appropriate providers invited to case conferencing? Example of providers include:

- Emergency Shelters
- Front Door providers
- ESG recipients
- CoC recipients
- Back@Home providers
- Managed Care Organizations (MCOs)
- Supportive Services for Veteran Families (SSVF)
- Public Housing Authorities (PHA)

Additional items to do while planning include: sharing the by-name list (securely) with your case conferencing team via email, requesting updates from agencies.

Questions to ask Emergency Shelters, Transitional Housing, and Street Outreach projects:

- Does the BNL show households your agency is no longer serving?
- Does the BNL show a complete list for each of the households your agency is
- currently serving?
- Does the BNL have correct and updated information for each one of the households

• your agency is currently serving?

Questions for Permanent Housing projects:

• Does the BNL show households your agency has housed or confirmed are no longer experiencing homelessness?

The next step is to draft the agenda, an example agenda could be:

- Opening/Introductions
- Announcements/Program Updates
- Consultations Cases that need advice but are not being presented for
- housing.
- Outreach Updates Cases that are unsheltered, at-risk of homelessness
- from Outreach Coordinator
- Prior Meeting Review and Updates Cases that have been presented
- and require follow-up; status reports on cases that have been referred to
- a housing program (ESG RRH, CoC RRH, PSH)
- New Referrals and By-Name List Review Cases for referral to a housing
- program
- Adjournment

#### **By-Name List: Review and Filter**

Allie Card presented an example of a by-name list and showed how to review and filter the list. For permanent housing:

- Highest VI-SPDAT score (individual and family)
- Sort column R (individual) or S (family) from largest to smallest
- Longest length of homelessness
- Filter column O (length of stay: days) or P (length of stay: cumulative)

#### PSH criteria

- Disability
  - o Filter column I to yes
- Chronic homelessness
  - o Filter column H to yes
- o If column H is blank, filter for the cumulative length of stay (column P) for over 365 days and disability (column I) to yes

#### **Emergency Housing Vouchers**

- o Priority 2: Households with highest length of unsheltered homelessness and where documentation for PSH (chronic homelessness and/or disability) is not able to be obtained.
  - Chronically homeless

- Filter column H to yes
- If column H is blank, filter for the cumulative length of stay (column P)
- for over 365 days and disability (column I) to yes
- Disability
  - Filter column I to yes
- Current living situation
  - Filter column U to "place not meant for human habitation"
- Length of stay
  - Filter column O and/or P
- Priority 3: Families and/or individuals on current regional Coordinated Entry byname list who need long-term rental assistance.
  - VI-SPDAT score
    - Sort column R (individual) or S (family) from largest to smallest
  - Length of stay
    - Filter column O (length of stay: days) or P (length of stay: cumulative)

Households without CE project entry

• Filter column K to no

Households without current living situation

Filter column U to blanks

Households without updated current living situation

• Filter column T to the color yellow and/or blank

Questions to ask regarding clients who have experienced domestic violence include:

- How are DV clients included in case conferencing?
- Usage of comparable database?
- Usage of encrypted excel documents?

For clients that present at agencies without HMIS and/or a comparable database questions to ask include:

- Who completes the VI-SPDAT?
- Who adds the household to the by-name list?

Case conferencing should include a robust discussion regarding non-HUD-funded resources. Examples include:

- Public Housing Authority
- Housing Opportunities for Persons with AIDS (HOPWA)
- Veteran Resources
- Low-Income Housing Tax Credit (LIHTC)
- Naturally occurring low-income housing

Ashley VonHatten suggested for regions to review their regional CE plans. Examples of questions to ask include:

- Does it explain the current CE process for the region?
  - o Diversion and prevention
  - o DV referral process
  - o By-name list and referrals
  - Grievance policy
- Does it include an accurate list of providers for the region?

#### **Emergency Housing Vouchers**

Allie Card reviewed the HUD EHV Dashboard, and provided updates and reminders.

- PHAs must lease up all allocated vouchers by December 31, 2022
- Send Referrals as soon as possible. She is setting up meetings with PHAs and CE Leads in regions

#### with low utilization

- RRH Step Up Threshold Change: 8+ months of RRH assistance
- Ported NCCIA referrals: Once a household is ported to a different PHA, reach out to the receiving PHA for updates

#### **Grievance Policy and Discussion**

According to the NC BoS CoC Coordinated Entry Written Standards Regional Committees must create a grievance process for participants and agencies using the system when they have a concern with decisions made by the coordinated entry system or agencies operating under said system. Local grievance procedures will handle the majority of issues. For issues that the local system cannot resolve, participants and/or agencies can appeal their concern to the BoS Coordinated Entry Council for resolution.

#### **Unsheltered Access Coordinator**

The UAC term is May 2022 through April 2023. Role and/or responsibilities include:

- Serve as primary contact for Regional Committee around unsheltered access
- Coordinate with regional Coordinated Entry Leads to ensure people
- experiencing unsheltered homelessness access the local coordinated entry
- system
- Ensure data collection happens on all people experiencing unsheltered
- homelessness
- Engage providers/organizations/stakeholders to understand the local plan to
- engage people experiencing unsheltered homelessness and how to connect

#### **CE Evaluations**

Permanent Supportive Housing (PSH): PSH clients who have entered a PSH program in the last year will be offered the opportunity to complete the coordinated entry evaluation survey that asks about their experience of the coordinated entry system.

• Timeframe for PSH survey is April 1, 2022, through May 31, 2022.

Rapid Rehousing: All clients housed by a rapid rehousing program in the CoC must receive this survey within 30 days (before or after) they are housed.

 CE surveys are located on NCCEH's website, under <u>BoS Coordinated Entry</u>, then click on information
