- 150 plus people to complete assessments on
- Anna Register is assisting on intakes
- Looking for a case manager for Scotland County area
- Encouraging assistance with finding additional landlords due to shortage of housing

8. Rapid Rehousing Program

- Funding renewed for Rapid Rehousing case management program
- Currently housed 25 families for the year
- Still accepting referrals
- Encouraging others to refer landlords to the program

9. HUD VASH/ Veteran Services Update

- Assisting Homeless Veterans with providing intensive case management for Veterans with physical, mental, and or substance abuse needs.
