**Covid-19 Response** – Duplin – Dr. Deniece shared that there will be a food box give away at the Duplin County Event Center on November 24, 2021 and Duplin is at 50% vaccinated; Greene – nothing new to share; Lenoir –Greene Lamp Angela shared that they are accepting application for families through the CARES Act, CSBG; Sampson, no update; Wayne, city of Goldsboro continue to provide food boxes and covid supplies and shelter ; Wilson – Linda with Hope Station continues to get clients in shelter vaccinated, and are working on getting contract with City of Wilson.

**Balance of State Short Summary** – this was shared with the group by LaTasha. Sent out by email to review at your leisure.

**Coordinated Entry** – Linda reported that the pit count will be submitted and continued training for unsheltered data entry, discussed grant cycle of CE process. Discuss who is responsible for point count of the unsheltered in each county.

**COC update** – LaTasha reported that application process has finalized. Two agencies that applied COC funds, Eastpoint renewed for 2022 and Greene Lamp, Application will not move forward and therefore will not receive funding, discussion was presented by Crystal around the application submittal issues. Concerns from Zachary, Dr. Deniece and Crystal were also discussed. LaTasha read the information from the meeting discussing the issues and LaTasha shared her screen with additional information.

### **ESG Project Updates**

Summary was presented by LaTasha, Hope station, Greene Lamp and Salvation Army

Annual ESG all applied, and the outcome was Greene Lamp received full funding plus additional \$18,000 fair share funds, Hope Station was approved with conditions (technical assistance) and Salvation Army was also approved with conditions but declined because they did not want to accept the conditions, they wanted to change to Rapid Re-Housing but was denied due to the time frame. No ESG Funds for Wayne or Duplin 2022 program year. Discussion was presented by Zachary and Captain Stephanie about Salvation Army decision.

# **Agency Updates**

Linda, presented Hope station updates, with budget requests, updated hotel assistance, they declined shelter funds for next year due to the low barrier request, Linda discussed various processes and requirements of her program and document was shared on screen by LaTasha Sharon, Presented Greene Lamp updates and the documents were shared on screen by LaTasha Captain Stephanie, Salvation Army was not prepared for update, LaTasha noted that if anyone has any guestions, please send them to her or Captain Stephanie.
