- Individuals listed on binding list have been contacted and proper measures taken to ensure assistance.
- 3 families awarded voucher and placed
- 3 still looking for housing
- 93 vouchers left
- 2 referral Scotland, 1 Bladen, 2 will be completed for Columbus county.
- 392 voucher out of 414 vouchers issued as reported by Brian Alexander.

10. B@H Program COVID

- 3 new families housed
- 384 called 211
- 80 families assisted
- 100 actively looking for housing
- 173 total housed
- Extended until December 2023
- All referrals asked to be given to Cicely Pighet
- 1.8 million dollars granted for housing assistance

11. Rapid Rehousing Program

- 31 Active families
- 16 individuals/families housed
- 15 individuals/families are searching for housing
- 27 on the waiting list for the Rapid Rehousing Program
- Currently looking for landlords

Permanent Supportive Housing

- 8 in program and all are full
- Working with 22 EHV vouchers available
- Working towards clearing those slots in order to assist more

- Hollie Oxendine reported that as referral come in and Clients are assessed and added to biname list.
