# NC MedAssist Presentation – Danny Szemple

- NC MedAssist is a free pharmacy program that provides free prescription medications who do not have the means to obtain the medications will be given a chance to appeal the decision, if necessary; over-the-counter medications are also offered during their mobile pharmacy events
- Eligibility requirements
  - o must be a North Carolina resident
  - o be uninsured no access to prescription drug coverage through Medicaid (exception for family planning Medicaid only), Medicare, VA insurance, or private health insurance
  - o have an income at or below 300% of the federal poverty level
- Visit the website for a list of medications that are available; there is no limit to the number of medications a patient can receive
- All applicants must provide an application, proof of address, proof on income or no income and taxes (if patient filed)

#### **Unsheltered Workbook**

• The committee was reminded that the information that is needed for the workbook is due next week to NCCEH – looking for agencies that perform street outreach in the region

#### **Emergency Housing Vouchers**

• NC Commission of Indian Affairs will stop taking referrals for the Emergency Housing Voucher Program on tomorrow (10/14/2022)

• 414 emergency housing vouchers were allocated, but 618 have been issued and 44 have been leased according to the HUD EHV Dashboard

#### **Regional Leadership**

- An election will be held in November to elect the following leadership roles to begin in January 2023: Regional Lead, Regional Alternate, Webmaster, Project Review Committee Representative, and Unsheltered Access Coordinator
