- Unsheltered PIT Count Planning
 - Like last year: Project Entry + PIT Night Living Situation = Unsheltered PIT Count
 - PIT Night 1/25/23
 - Roles include Unsheltered Access Coordinators, CE Leads, Community Partners/volunteers
 - Unsheltered PIT Count Data Input:
 - Survey potentially unsheltered clients in person or via phone, ask about PIT night sleeping situation specifically, surveys are valid within 7 days after 1/25/23
 - Complete missing Project Entry Info (age, race, ethnicity, gender, vet status, DV status, & homeless history if possible)
 - Enter current living situation record in HMS or alternative BNL for VSPs, Record for PIT date to confirm for PIT, Record as 'Place not meant for human habitation' for unsheltered
 - Start Prepping now update & send BoS unsheltered workbooks, outreach & partnership in regions, attend January PIT meetings,
- Coordinated Entry Update (Greta)
 - o Greta shared received email from Ashley Von Hatten NCCEH/ Balance of State regarding \$100 Visa gift card for Unsheltered CE/PIT Access!! Each Regional Coordinated Entry Lead will receive a \$100 Visa gift card (via mail) and will coordinate their spending with the Unsheltered Access Coordinator and/or Regional Lead. The gift card is intended to connect with people living unsheltered directly or indirectly with the help of volunteers. Items that might be purchased:
 - Socks, gloves, warm clothing
 - Hygiene kits

- Convenient food like granola bars
- Water bottles
- Printed materials about CE Access Points and seasonal shelter
- Weather-related supplies
- Timeline: Mailing of gift cards is expected for the week of December 5, 2022, to allow for potential online orders of supplies to be delivered.
- Rapid Rehousing Update (Greta)
 - O To date 37 people assisted (12 children, 25 adults housed; 18 households (4 adults, 9 children, 4 families, 16 adults)
 - Awarded \$55,000, Spent \$35,179.98, \$9,820.02 to be spent by 12/31/22
 - Couple of checks to be sent in December covering rent in January
- Permanent Supportive Housing Update (Derek Lancour)
 - 40 households served (still below grant minimum)
 - 34 current housed households (6 looking for housing)
 - 69 total persons served
 - 55 adults
 - 14 children
 - 1 successfully exit since last meeting (4-person household)
 - 1 household added 3 new household members and they were successfully rehoused recently
 - o 1 new PSH household has identified housing and they are awaiting repairs (estimated move in would be 1/1/23)
 - o PSH spending through 6 months
 - Just over 36%
 - Minimum goal would be 45%
 - Spending behind by about 9% from minimum goal currently

 - Four Square Community Action Dan Ferreira Hired social worker to start soon;
 interested in helping w/PIT; offices in Cherokee, Clay, Graham, Swain
