





## **CY24 ESG Competition is here!**

- The competition timeline has been moved up about 5 weeks from last year.
- Coordinated Entry Leads are vital to the competition!
- Today we will briefly cover ESG basics, timeline, funding amounts and your role in the competition.



## **ESG: Emergency Solutions Grants**

Purpose:

- Provide assistance to rapidly rehouse persons who are currently experiencing homelessness
- Assist in meeting the costs of operating emergency shelters
- Decrease homelessness through the provision of preventive programs and activities




## HUD sets priorities for the ESG program.

- Broaden existing emergency shelter and homelessness prevention activities
- Emphasize rapid rehousing
- Help people quickly regain stability in permanent housing after experiencing a housing crisis and/or homelessness

For every activity type, ESG funding should be assisting people to access or maintain permanent housing!



## **5 eligible components under ESG**






## Key eligibility criteria for ESG subrecipients

- Must be a 501(c)3 or a unit of local government
  - Public Housing Authorities (PHAs) are not eligible for ESG funds.
- ESG funds cannot be used for transitional housing (TH) projects.
- ESG funds cannot be used for capital improvement projects, new construction, or retail acquisition. These funds can be used for facility maintenance of existing program space.



## **Conflict-of-Interest Policy**

- Persons attending Steering Committee or Regional Committee meeting representing an agency applying for CY24 ESG Annual Allocation Funding may <u>not</u>:
  - Participate in conversation about applicants
  - Facilitate Regional Committee meetings to recommend agencies for funding.
  - Ask questions about the funding proposal for your agency
  - Make a motion related to approving or recommending an agency for funding.
  - Vote on the Regional Prioritization Form or proposed slate of applicants (Steering Committee meeting only)



### What is the Regional Prioritization Form?

#### The Regional Prioritization Form IS:

- An opportunity for Regional Committees to provide input on the applicants in their region applying for ESG funding.
- An opportunity to notify NCCEH staff and the Project Review Committee if an agency applied for ESG funds that does not participate in Regional Committee and case conferencing meetings.

#### The Regional Prioritization Form IS NOT:

- A final decision on which projects are funded.
- A decision regarding the funding amount awarded to any project applicant.



# When is the Regional Prioritization Form completed?



The Regional Prioritization Form will be sent to Regional Leads and Alternates once the initial application review has been completed by NCCEH staff and the Project Review Committee.



It will need to be completed and returned by the assigned deadline (date TBD) in order to be considered by the Project Review Committee in creating the proposed slate of applications.




# What is required to complete the Regional Prioritization Form?

- A special meeting of your regional committee will need to be called and facilitated by a leader who does not have a conflict of interest.
- Unlike the form from last year, no funding amounts will be included.
- The form will ask for a 'yes/no' response to recommend each project for funding.
- The form also includes verification that applicant agencies attended a benchmark of 75% of Regional Committee meetings (per agency), and 75% of by-name-list meetings (per project).
  - This may mean the regional Webmasters and Coordinated Entry Leads need to find this data ahead of the Regional Committee meeting.

## **Unsheltered PIT**

- Our goal is NOT to count unsheltered households on the night of Point In Time.
- Our goal is to connected unsheltered households to coordinated entry, services, and permanent housing.
- Please ensure agencies are following up with clients living unsheltered and working to get the household assessed and connected to resources.
- Please exit households from the appropriate project if no contact can be made after 90 days.




## **Unsheltered PIT**

- Reminder: Your goal is to ensure all people living unsheltered connect to services!
  - Build trusting relationships
  - Collect contact information for follow-up
  - Refer to emergency shelter, when possible
  - Assess and refer to coordinated entry
  - Connect to services and permanent housing
- Elected term is May April
  - Missing UACs from Regions 3, 5, 6, 8, and 11
  - Please submit Regional UAC information through <u>Smartsheet</u>
  - In-person meeting on June 15, 2023, to provide support to all UACs

## The CoC has launched it 2023 CE Evaluation.

- In accordance with <u>HUD Coordinated Entry Notice: Section II.B.15</u>, the CoC began its CE evaluation process on **April 3, 2023**.
- HUD requires CoCs to solicit feedback at least annually from participating projects & from households that participated in CE during that time period.
- Surveys must address the quality & effectiveness of the entire CE experience for both participating projects & households.
- The CoC CE Council voted on 03/20/23, setting a timeline for survey distribution for CoC stakeholders & CE participants.



## The CoC has launched it 2023 CE Evaluation.

Permanent Supportive Housing (PSH): PSH clients who have entered a PSH program in the last year will be offered the opportunity to complete the coordinated entry evaluation survey that asks about their experience of the coordinated entry system.

• Timeframe for PSH survey is April 3, 2023, through May 26, 2023.


Shelters &/or Street Outreach: All people completing the VI-SPDAT will be offered the opportunity to complete the coordinated entry evaluation survey that asks about their experience of the coordinated entry system.

• Timeframe for Shelter and/or Street Outreach is May 15, 2023, through May 26, 2023.

Rapid Rehousing: All clients housed by a rapid rehousing program in the CoC must receive this survey within 30 days (before or after) they are housed. Ongoing.
