Classic Scenario of an SSI Approval

Confirmed Diagnosis + 1 year of medical treatment or medication use; failed intervention + Health Crises: Major Surgery or Several Recent Hospitalizations + Still unable to control the health limitations after 1 year + Less than \$2000 in the bank + Not capable of working ever again due to health

Classic Scenarios of a Disability Claim Denial

Symptoms only occur while using substances

or

Several hospitalizations but only for detox

or No routine doctor visits; not on any medications; no healthcare in years or Recent diagnosis within last 3-6 months (not 1 year yet) or

Has pain or health issues but no surgery or mult. ER visits (no crisis)

or

Had a job within the past year and made \$345/week gross

or

Had unusual symptoms but not seen by a doctor yet at all

ELIGIBILITY CRITERIA

To assess SOAR eligibility, we are looking for basic information on:

- SEVERE limitation in daily functioning due to medical and/or psychiatric conditions (i.e., trouble walking, standing, breathing, understanding, etc.)
- The ongoing presence of a CHRONIC medical and/or psychiatric diagnosis (i.e., schizophrenia, liver failure)

RECENT doctor's visit within past 6 months (i.e., labs, physical exam, x-ray, mental eval, surgery, ER visits) or a history of treatment for conditions (can also be school records for IEP/special education classes/low IQ)

 Inability to work and earn SGA (\$1,470/month in 2023) due to medical and/or psychiatric conditions (not because he/she cannot find work or was laid off; he/she cannot even handle working as a Walmart greeter)

*once you've identified that ALL the above criteria is met, proceed to the attached Referral Form

*As guests are registering for services at Oak City Cares, pre-screen for possible Disability candidates to refer to SOAR Specialist. Due to the strict criteria of the SSA Disability program there needs to be a general understanding by Intake Staff of **WHAT IT IS NOT!** (the following examples are highly likely to be DENIED)

It is **NOT**:

- It is NOT the same as VA Disability... "I am 100% disabled per the VA"
- It is NOT given to everyone with a diagnosis... "I have had asthma my whole life"
- It is NOT funds for the poor in general... "I need to buy my blood pressure/diabetes medicine"
- It is NOT for mild-to-moderate symptoms or limitations ... "My back aches after cleaning the house but I am able to push through" OR "My vision is a little blurred but I still drive" OR "My memory isn't as sharp as it used to be"
- It is NOT given because you applied 3 times, there's no "Third Time's the Charm" magic
- It is NOT rehab for addicts. Very difficult to get disability approval for drug & alcohol addictions.

Likely Approval	Likely Denial
Severe symptoms- ex: required major surgery, suicidal thoughts	Mild symptoms – ex: headache, dizziness, nausea, fatigue, sadness
Extreme symptoms- ex: attempted self-harm x3, two major surgeries	Moderate symptoms – ex: pain, numbness, stiffness, depressed, anxious
Records for many years are consistent at the same level of severity	No Doctor has ever seen them for this severe condition; self-diagnosed
Multiple ER visits & there were no substances on Urine Drug Screen	Diagnosed but intoxicated at the time of the visit (drugs &/or alcohol)
Followed doctors' orders to a 'T' & the condition worsened over time	Diagnosed but never followed through on any treatment (ex-Rx meds)
Diagnosed, had major surgery, takes all Rx, condition still unstable	Diagnosed, sees doctor routinely, takes all meds, condition is now stable
Diagnosed with a severe condition 1 year ago and it is still not stable	Diagnosed with a severe condition however it was very recent- last week
Had to go to Emergency Room or was Hospitalized multiple times 3+	Had to go to Emergency Room or was Hospitalized but only once ever
Cannot feed themselves, wheelchair bound, cannot walk after 1 year	Extreme symptoms, major surgeries, multiple ER visits but held a job
Extreme condition, 1 year of physical therapy but never recovered	Extreme condition, 6 months of physical therapy but regained mobility

Was any substance in your system when you went?	Yes, but I have been clean for 2 months	I drank when I was younger but none in years
When is the last time you worked?	I had to quit recently OR I don't remember	I haven't been able to hold down a job in 1 yr
What are some things you can no longer do?	I can't do nothing, it's hard to stand all day	I hate that someone else has to dress me
Have you ever seen a doctor for this?	No, I hate doctors & hospitals, refuse to go	I have a specialist and go every month
Do you take all of your meds?	No, because I cannot afford them, no insur	They've tried me on several meds, none help

GOAL: Compliance with Doctor's Treatment plan + Long Term Permanent Condition + Clean from Substances + Not Able to Function = Likely SSI

Some Go-To Phrases to say: Continue to use the 1st page of the Referral Form with the 4 criteria.

- 1. "SSA will base your disability solely on medical records so let's build up your paper trail with medical care and mental health treatment first before considering applying. What medical intervention has been done?"
- 2. "SSA's criteria is so strict for approval that you cannot be able to work any job at all. You were working last month full time and would not be considered permanently disabled just yet."
- 3. "SSA will not award benefits for conditions that were induced by drugs/alcohol, let's get you detoxed first"
- 4. IF SOMEONE IS INSISTENT: "You are more than welcome to apply on your own directly at SSA but our SOAR program provides thorough case management and researches all your medical records for your disability claim. If you have no current medical records to prove you're disabled, you won't need SOAR services. Here is their ph # and address.
- 5. "SSA's Disability is not based on a diagnosis alone but rather how severe the diagnosis got. ER visits and surgeries determine severity. Have you been in/out the hospital a lot? Or had any major surgeries yet?"
- 6. "Think of filing for disability as a Last Resort after all medical intervention failed for your condition. When is the last time you worked and what medical intervention has been done."

Likely NOT a good SOAR candidate	Possibly a good SOAR candidate
Out of meds and health is declining	Takes meds regularly and health is declining still
No treating physician or mental health provider	Has a few doctors and likely a specialist or two
Can't afford meds or medical care	Has insurance and no barriers to getting their Rx
Not seen a doctor in a while	Sees their doctor regularly or has routine therapy
Never been to the hospital/ER for the condition	Medical or mental health crisis landing in ER mult x's
Never had a surgery for the condition	Major surgery or medical intervention and it failed
Struggling with addictions (drugs/alcohol) or used to	No drugs or alcohol in system when they went to ER
Worked within the past year	Job Pattern is clearly in sync with Decline in Health
No working phone yet (have them return after rcvd)	Has a working phone open line of communication
65 years old and has worked a lot, I want to retire	65 years old, hasn't worked a lot in life or in general
New recent diagnosis from recent doctor appt	Discovered tumor 1 yr ago, it returned after chemo
Already gets a SSI check or SSDI check or disability	Do not need a SOAR case manager for your check
Not homeless but wants a SOAR rep	SOAR is only for the homeless disabled population
Has lots of medical conditions but refuses treatment or hates hospitals	SOAR is a method of applying for SSI by researching their records and sending complete packets of info (no records = no need for SOAR)
