NCCEH Update

Dear friends,

We are ending this year with positive news: Homeless numbers are decreasing. I bet this is the opposite of what most people think and hear in news headlines.

Throughout this year, we've been surrounded by stories of heartache and hardship. You probably would have expected that when HUD released the national 2011 Point-in-Time count numbers they would be announcing large numbers that were reflective of the recession.

But that isn't the case. In fact, overall homeless numbers showed a 2.1% decrease from 2010! There was an even larger decrease amongst homeless veterans. HUD reported a 12% decrease among veterans experiencing homelessness from 2010 to 2011!

While most of country will be surprised to hear those numbers, I am not. Over the past few years, I've continued to hear stories of increased need, but I'm also hearing and seeing more stories of success than ever before.

The real story is that even in a time of great economic difficulty, we can implement solutions that get results. In order to keep these numbers decreasing and keep people out of shelters and homelessness, we need to meet the growing need, which means continuing our focus on programs that work.

When I reflect on the past year, a few things stand out that have produced results:

- Using new resources and retooling existing resources to focus on housing stability
- Targeting to get the right resources to the right people
- Becoming more effective and efficient by investing in solutions that have the best outcomes: Rapid Re-Housing and Permanent Supportive Housing

The decrease in homelessness, especially at such a difficult time, proves we are on the right track. We have proven that the assistance that HPRP offers works. Rental assistance, financial assistance and case management on a short-term basis are what get and keep people in housing. While HPRP funds will end in 2012, we must continue the programs that HPRP created. The challenge for 2012 will be to retool existing resources to continue to offer and expand these essential services.

On January 25, 2012, communities in North Carolina will conduct our annual point-in-time count. Of course, we're all anxious to see what the new numbers will show. We've learned some invaluable lessons in 2011. NCCEH staff crisscrossed the state working with communities to retool and access new funding. In 2012, we'll be focusing on sharing these lessons that we've learned right here in North Carolina.

The staff and board of NCCEH sincerely thank you all for your partnership and commitment in ending homelessness. We look forward to working with you in 2012.
