NCCEH Update

Dear friends,

A lot has happened since our last update went out. We're seeing a lot of success in the face of continued changes and a couple of new obstacles. Here's a rundown of what's happened in the last six weeks:

- HUD released the Continuum of Care regulations. These much-anticipated regulations give us a clearer picture of how HUD intends to run the Continuum of Care competition and gives CoCs more tools for running effective and cost-efficient systems to end homelessness.
- The State released the first Emergency Solutions Grants Application. The State has made significant changes to the application to encourage communities to retool their crisis response systems, including an emphasis on funding rapid re-housing programs. (Take advantage of NCCEH's ESG consultation offer below!)
- The CHIN Advisory Committee has been holding important discussions in order to ensure communities' ability to comply with HEARTH and to use performance measures to improve systems. Charlotte's CoC voted to join CHIN, becoming the 100th county to join CHIN in what is now a state-wide homeless management information system.
- Over 60 individuals from North Carolina attended the National Alliance to End Homelessness Annual Conference in Washington, D.C. last week. We all were inspired, educated, and challenged. NCCEH staff led the group to the Hill for congressional meetings.
- The Department of Veterans Affairs released its second round of funding for the Supportive Services for Veterans Families program. Programs in Raleigh, Winston-Salem, and Asheville received funding to implement this rapid re-housing program.
- NCCEH held a call about former residents of Adult Care Homes coming into our homeless system. It's important to track these individuals so we can do our best to ensure their access to resources. You can track individuals in CHIN and through our reporting process. (See below to read the notes from the call to find out more.)
- The NC General Assembly did not include funding for the North Carolina Interagency Council for Coordinating Homeless Programs (NC ICCHP). This council has funded the Balance of State CoC, NC SOAR, training and technical assistance for communities and agencies, Ten-Year Plans, CHIN, and research on the cost-effectiveness of permanent supportive housing. Senators' and Representatives' offices

were flooded with your calls and emails. While the funding was not included, your advocacy efforts did make an impact! We look forward to continuing to work with you in order to restore the NC ICCHP funding next year. At this point, we are hoping DHHS will step up and cover the cost of some of these important programs. NCCEH Board and staff are committed to continuing to advocate to secure this funding.

Through all of these successes and challenges, we are grateful for your partnership. We continue to take great strides in ending homelessness. The new federal rules and resources that we advocated for will help us continue to see more progress.

We must have the State as a partner in order to fully take advantage of these opportunities. Membership dues enable us to advocate at the state level for needed policy improvements and funding.

Tracking New Homeless from Adult Care Homes

After receiving reports from two different shelters that former residents of Adult Care Homes (ACHs) were appearing in the shelter system, NCCEH held a webinar on July 9th.

Changes in how some Adult Care Homes are able to bill Medicaid may lead to more individuals needing shelter.

This issue is related to, but is NOT because of, the Department of Justice's investigation on North Carolina's Olmstead Act infractions.

These issues are explained and resources are shared in the [transcript from the webinar](#). All homeless providers (including shelters, transitional housing, and outreach) should begin tracking former ACH residents in CHIN and use NCCEH's reporting process. Instructions are included in the transcript.

HUD Releases CoC Program Interim Regulations

The HEARTH Act consolidates all of HUD's competitive homeless assistance grants into a single, new program: the Continuum of Care Program. On July 14, HUD released the [interim regulations](#) for the CoC Program.

The interim regulation will be effective 30 days after publication in the Federal Register. HUD is encouraging

stakeholders to comment on the regulations once they're published; comments are due by 60 days after the publication date.

HUD has also created an [Introductory Guide to the CoC Program](#), a 16-page document that summarizes CoC responsibilities, program components and requirements, and eligible costs under the new CoC Program.

The CoC Program will change the way NC communities apply for and implement federal funding for homeless programs. We encourage all communities to read the regulations and guide!
