## Comments on Con Plan's Annual Action Plan

The State has composed its draft Annual Action Plan for its Consolidated Plan, which guides the use of CDBG, ESG, HOME, and HOPWA funds.

NCCEH has submitted comments on the Annual Action Plan encouraging the state to invest more resources in rapid re-housing programs to re-house homeless individuals and families.

## Comment on CoC Program Interim Regulations

The interim regulation for the Continuum of Care (CoC) Program went into effect on August 30. HUD is accepting comments on the interim regulation until Friday, November 16. HUD will take these comments into consideration when it is writing the final rule for the CoC Program.

We strongly encourage you to [read the interim regulation](#) and to submit comments to HUD. The final regulation will determine which tools and resources will be available to your community to prevent and end homelessness, so it's important for HUD to hear your views!
