3: CHIN MOU

- <u>CHIN MOU</u> (doc available on BoS webpage)
- CHIN Advisory Committee finalized MOU
 - To be signed by each CoC in NC
 - Changes the governance structure of CHIN, changing the Advisory Committee to the Governance Committee
 - Outlines responsibilities for CHIN Governance Committee, HMIS Lead Agency, and CoCs
- NC DHHS is lead agency and signatory authority for Balance of State CoC
 - After the SC agenda went out, the CHIN Advisory Committee notified CoCs that there will be changes made to the MOU
 - DHHS will ask Steering Committee to approve the MOU for signature by DHHS after an updated MOU has been received

4: Coordinated Assessment

- Vision Statement
 - Coordinated Assessment assists the NC BoS CoC to end homelessness by increasing exits to housing, decreasing length of time homeless and reducing returns to homelessness. Consumers will quickly access appropriate services to address housing crises through a right-sized, well-coordinated agency network.

4: Coordinated Assessment, Cont.

- Guiding Principles
 - Sustainable
 - Flexible
 - Transparent and Accountable
 - Housing-focused
 - Client-focused
 - Collaboration-focused
 - Easy to use

4: Coordinated Assessment, Cont.

- Proposed process
 - Decentralized, localized model
 - Designed and administered at Regional Committee level
 - Standards and governance from Steering Committee
- How it will work
 - Each Regional Committee will design local Coordinated Assessment system
 - CA systems will all fall within parameters set by Steering Committee
 - Will include Coordinated Assessment Toolkit

4: Coordinated Assessment, Cont.

- Coordinated Assessment Toolkit
 - Vision statement
 - Guiding principles
 - Menu of 2-3 Coordinated Assessment models
 - Assessment tool
 - Shared across NC BoS everyone using the same assessment pieces
 - Component pieces
 - Regional Committees can assemble
 - Based on locally available services
 - Sample MOUs or other written agreements

- NCCEH staff contacting CHIN users not in compliance with No Fee License Policy
 - Reclaim license if unused/unwanted
 - Make a plan for user to comply with policy
- CHIN agencies that want to increase/decrease number of CHIN licenses now-June 2014
 - Complete and submit Call for Information form by November 30

7: AHAR

- Report to Congress on extent & nature of homelessness in USA
 - HMIS data (homelessness during 12-month period)
 - PIT Count data (homelessness on a single night)
- AHAR participation is important
 - Scored in CoC application
 - Helps HUD / Congress get accurate picture of our communities
- NCCEH works with CHIN to submit BoS AHAR data to HUD
- 2013 AHAR Deadlines:
 - Draft data: November 15
 - Final data: December 13

7: AHAR, Cont.

- Must have good data quality to be allowed to contribute
- All CHIN Users: Run AHAR Check Report in ART
 - Fix missing and incorrect data
 - Missing veteran status
 - Missing ZIP codes
 - Missing exit destination from PSH programs
 - All other missing data
 - Children checked in without parents/guardians
 - Check for "suspicious" data (individuals if your program only serves families, PSH exits to shelters, etc.)
