# **HMIS Update**

#### NC HMIS

- NC HMIS covers all 12 CoCs in North Carolina
- Governance Committee provides oversight
- MCAH began as NC HMIS Administrator in May 2015
- NCCEH board & staff sent letter to Governance Committee on July 27, 2017 requesting RFP to explore other options
- NCCEH remains committed to statewide system, however we must be able to fulfill our responsibilities to Balance of State as the Collaborative Applicant and HMIS Grantee in order to remain a part of the statewide system
- NCCEH requesting HUD Technical Assistance
- Governance Committee meets August 14, then monthly
- NCCEH board will evaluate and make decision at November 17 board meeting



# CoC Grant Significant Changes Policy

# NCCEH staff have created a policy for CoC grant significant changes

- Significant changes are occasionally needed to effectively implement CoC grants
- Grantees are required to receive approval from HUD
- Grantees must also involve the CoC
  - Grant was approved by CoC/Steering Committee based on initial application
  - Significant changes are a departure from initial application & need approval



# Significant changes substantially affect grant implementation.

- Change of recipient (grant transfer) or subrecipient
- Change of project site (location)
- Addition/elimination of budget line items
- Shift of more that 10% from one budget line item to another
- Permanent change in subpopulation served
- Permanent reduction in number of units
- Closure of project or voluntary relinquishment of funding

## 2017 CoC Competition

### The CoC application is now open.

- HUD released the CoC NOFA on July 14
- The CoC consolidated application is due September 28
- CoC consolidated application has 3 parts
- 1. CoC application: CoC-wide info, completed by BoS staff with input from agencies, Steering Committee, other stakeholders
- 2. Project applications: individual applications from agencies for new and renewal projects
- 3. Project priority listing: ranked list of project applications, recommended by Project Review Committee and approved by Steering Committee

## HUD uses calculations to determine each CoC's available funding.

BoS can apply for up to \$9,249,857

- Annual Renewal Demand (ARD): all renewal projects
  - \$8,267,704
- PH Bonus for new projects: 5% of pro rata
  - \$654,769
- CoC Planning: 3% of pro rata
  - \$327,384



# Funding for new projects is available through the PH Bonus & reallocation.

PH Bonus funds are available for new projects

• The Project Review Committee may also choose to reallocate funds from low-performing renewals to create new projects.



#### CoCs will continue to place projects in 2 tiers.

- Change: Tier 1 now 94% of ARD instead of 93%
  - Allows CoCs to place more projects in relatively safe
     Tier 1

- Tier 1: 94% of ARD
  - \$7,771,642
- Tier 2: 6% of ARD plus PH Bonus
  - \$1,150,831



#### CoC application timeline

- August 4: First due date for project application materials
- August 18: Second due date for project application materials
- August 22: Project Review Committee holds first meeting
- **August 24–31:** Project Review Committee reviews & scores applications
- **September 5:** Steering Committee meeting
- September 8: Project Review Committee meets to create ranked list of projects
- **September 12:** Special Steering Committee meeting to approve ranked list of projects
- **September 13:** Project applicants notified if project included in final application
- **September 21:** Project applicants hit submit in esnaps
- September 28: CoC application due to HUD

#### What's new in esnaps

- Fewer attachments in applicant profile
  - Some have been moved into profile or application itself

- Option for renewals to submit without changes
  - Most PSH grantees need some changes (100% dedicated CH beds, geographic areas served)
  - RRH grantees may not need changes
  - Check with NCCEH staff first!



## NOFA has options that BoS will <u>not</u> take advantage of this year

- New component program TH-RRH
  - Projects that have both transitional housing and rapid rehousing services
  - Assists households with bridge housing while waiting for permanent housing
  - For communities who have:
    - Lowered barriers in their existing shelters AND
    - Short lengths of stay in shelter but,
    - Still run out of shelter beds or have high numbers of unsheltered people



## NOFA has options that BoS will <u>not</u> take advantage of this year

- New option for DedicatedPLUS in PSH
  - Designation opens PSH to other populations besides households experiencing chronic homelessness
  - Targets those with long histories of homelessness/chronic disabling conditions but cannot meet chronic definition
  - For communities who have:
    - Nearly completed the job of ending chronic homelessness



## Two current CoC grantees have decided to stop operating their projects

- United Community Ministries in Rocky Mount will close out current grant on 08/31/17
  - Trillium Health Resources has agreed to take over the grant renewal starting 09/01/17
- Asheboro Housing Authority in Randolph County will close out current grant on 09/30/17
  - Volunteers of America Carolinas has agreed to take over the grant renewal starting 10/01/17
- Per significant change policy, Steering Committee needs to approve transfers
  - Discussion? Motion?



## **ESG Competition Update**

## Staff are preparing Regional Committees for the ESG process

- Staff have reached out to Funding Process Leads to schedule phone call about this year's competition
  - Design of process
  - Questions to ask and answer
  - Focus on capacity of agencies chosen to:
    - Spend funding
    - Operate program component per Written Standards
    - Administer a federal program
- Do not have a scheduled call yet with:
  - Regions 1, 2, 3, 4, 5, 6, 7, 11, or 12

## ESG application process will begin in August

- ESG application expected timeline:
  - Application release: Week of August 21
  - Deadline: October 15
  - Announcement and Contracts: December 1
  - Contracts Due: December 31
  - Project Start: January 1, 2018
- ESG regional and project applications are being updated currently
  - NCCEH staff are working on a voluntary scorecard for Regional Committees

- Most basically, we need to have a functional coordinated assessment system that covers ALL counties in the CoC by January 2018.

## SSVF providers are developing by-name lists in every region

- They will be rolling out a process to track by-name lists in HMIS.
- We need everyone's support and participation in this process! If we don't have every agency participating, we can't end Veteran homelessness in the NC BoS.



#### What's needed to create by-name lists

- Help identify Veterans and track them in HMIS.
- Help SSVF identify Veterans and get new ROIs signed.
- Sign the QSOBAA (sharing agreement) for HMIS byname list tracking.
- Participate in local meetings, track some additional data in HMIS, etc.



#### By-name lists in HMIS webinar

- The webinar will cover how to pull and use the by-name list report from HMIS and how to use a new Veterans assessment in HMIS.
